II. Approval of Minutes from Previous Board Meeting

III. Committee Reports

Bylaws Committee

Ms. Payne called on Ms. Stephanie Denton to provide the Bylaws Committee report on behalf of CAPT Brown. Ms. Denton reported that on October 30, 2023, the Bylaws Committee met remotely, via Microsoft Teams. Ms. Denton reported that CAPT Brown announced that old business included a change in the Bylaws where the organization name was updated to Probation and Pretrial Services Office (PPSO). Office of Accreditation Update

16 - Accredited Academies, and

96 - Accredited Programs

Mr. Collins reported a summary of annual reports received was included in the Board materials and complete copy of each report was available for review in the electronic Board materials.

Mr. Collins also reported that the next meeting will begin Tuesday, May 7 and conclude on Thursday, May 9, 2024. The location is to be determined.

VI. Old Business

Ms. Payne reported the following old business:

- 1. During this meeting, the Board received legislative updates.
 - a. The DHS Basic Training Accreditation Improvement Act of 2023 (H.R. 4406) was introduced June 30, 2023, in the 118th Congress. It was sponsored by Representative Luis Correa (CA) and has been referred to the Committee on Homeland Security, and the Committee on the Judiciary. As of October 4, 2023, the bill has had one markup.

- b. In addition, the Board was briefed on the latest status of Executive Order on Advancing Effective, Accountable Policing and Criminal Justice Practices to Enhance Public Trust and Public Safety (EO 14074). The Board is not currently aware of anything additional that will impact FLETA.
- c. Also, as mentioned at the previous Board Meeting, it is anticipated that law enforcement issues will continue to be a significant focus of the 118th Congress. Again, any impacts on FLETA will be monitored by the Office of Accreditation. The OA continues to provide Congressional Staff briefings and data calls on a regular basis.
- 2. The FLETA 2025 Comprehensive Standards Review has had its initial kick-off meeting on October 19, 2023, and will continue its work in 2024.
 - a. The Committee is chaired by the Second Vice-Chair Reed Stephenson and assisted by FLETA OA PM J.J. Hensley.
 - b. Thanks to all the Board members and community members for volunteering to be part of this very important endeavor.
- 3. The FLETA OA Program Review preparation work continues by the Office of Accreditation.
 - a. The committee is chaired by the Second Vice-Chair Reed and assisted by FLETA OA PM Jennifer Kasper. Other Committee members will be:
 - i. Board Member Stephanie Denton
 - ii. FLETA Community Member Haether Brown
 - b. The review will look at the administrative and operational functions of the OA and determine if the OA is meeting or exceeding the goals of the FLETA Strategic Plan.
 - c. The review will take place the week of December 4-8, 2023.

VII. New Business

- 1. The Board reviewed the composition of the Board and six Board terms that are due to expire September 30, 2024. In accordance with the bylaws, the Executive Secretary will coordinate with the current members to obtain a letter for continued participation on the Board.

IX. Awarding of Accreditation

Ms. Payne called upon First-Vice Chair Robert Lachance to introduce the presenters and agencies receiving accreditation.

Mr. Lachance recognized Board Review Committee A led by himself. Board members included: Stephanie Denton, Matt Hershey, Charles Lombard, Jr., Patrick Ruettiger, Reed Stephenson, and Miltom Wilson.

This committee reviewed one academy for reaccreditation and four programs for reaccreditation. They were assisted by FLETA OA Program Manager Jennifer Kasper.

Naval Criminal Investigative Service (NCIS) Training Academy

Mr. Lachance called upon Ms. Stephanie Denton to recognize the Naval Criminal Investigative Service (NCIS) Training Academy for its fourth reaccreditation. The dates of the assessment were August 7-9, 2023 by means of a remote assessment, and the Team Leader was Tonya Lopez, FLETC. The accreditation manager was Cassie Morazan.

The mission of the NCIS Training Academy is to provide relevant, timely, substantive, and cost-effective training programs that supply the tools needed to build a highly skilled NCIS workforce. The Academy's goal is to ensure training supports U.S. naval forces to

fight and prevail in conventional wars, insurgencies, piracy, and other challenges ashore, at sea, and in cyberspace.

Transportation Security Administration Training Center, Federal Air Marshal Training Program - II

Mr. Lachance called upon Mr. Charles Lombard, Jr. to recognize the Transportation Security Administration Training Center Federal Air Marshal Training Program - II for its fourth reaccreditation. The dates of the assessment were June 13-15, 2023 by means of a blended assessment (Atlantic City, NJ & Remote, and the Team Leader was Cyndi Pixley, PhD, FBI. The accreditation manager was Darrin Brown.

The purpose of the FAMTP - II is to develop the basic law enforcement training FAM Candidates (F/C) received from the Federal Law Enforcement Training Center's Federal Air Marshal Training Program – I, in an agency specific setting. FAMTP – II provides F/Cs training specific to transportation security, particularly the aviation domain, adapting physical skills such as firearms and defensive measures for safe application within the domain. The FAMTP – II is 43 instructional days and consists of 344 hours of instruction. The average number of students per iteration of the program is 24.

United States Coast Guard Maritime Law Enforcement Academy, Maritime Law Enforcement Facilitator Course

Mr. Lachance called upon Mr. Reed Stephenson to recognize the United States Coast Guard Maritime Law Enforcement Academy, Maritime Law Enforcement Facilitator Course for its third reaccreditation. The dates of the assessment were July 25-27, 2023 by means of a blended assessment (Charleston, SC & Remote), and the Team Leader was Rhonda Meehan, DCSA. The accreditation manager was Mike Sicard.

The purpose of the MLEFC is to prepare MLEA facilitators to deliver effective and efficient facilitated training to support the LE mission of the USCG. The MLEFC uses a variety of instructional methods to deliver and demonstrate facilitation training techniques. Students demonstrate knowledge of each competency using skill checks and demonstrate the ability to implement them by preparing for and delivering practice scenarios, feedback, and evaluation. The MLEFC is three instructional days and consists of 24 hours of instructions. The average number of students per iteration of the program is 22.

Drug Enforcement Administration, Basic Intelligence Research Specialist Training Program

Mr. Lachance called upon Mr. Patrick Ruettiger to recognize the Drug Enforcement Administration, Basic Intelligence Research Specialist Training Program for its first reaccreditation. The dates of the assessment were August 15-17, 2023 by means of a blended assessment (Quantico, VA & Remote), and the Team Leader was Adam Harper, FLETC. The accreditation manager was Natasha Harris.

The purpose of the BIRS is to train students to perform duties as an Intelligence Research Specialist. The primary functions of an Intelligence Research Specialist are to collect, collate, evaluate, analyze, and disseminate all available information on a particular operation, investigation, organization, drug-related issues, program, or project in support of DEA's mission. The program is a 10-week training program. The average number of students per iteration of the program is 30.

Federal Reserve System, Federal Reserve Basic Law Enforcement Course

Mr. Lachance called upon Mr. Wiltom Wilson to recognize the Federal Reserve System, Federal Reserve Basic Law Enforcement Course for its fourth reaccreditation. The dates of the assessment were August 22-24, 2023 by means of an in-person assessment, and the Team Leader was Julie Altman, FLETC. The accreditation manager was Ivan Biss.

The purpose of the BLEC is to provide training to basic entry level law enforcement officers who work in a Federal Bank infrastructure protection environment. The training includes the protection of the people, assets, and property of the Federal Reserve System. The BLEC is 36 instructional days and consists of 219 hours of instruction. The average number of students per iteration of the program is 12.

Mr. Lachance recognized Board Review Committee B led by Ms. Tracy Siler. Board members included: Brent Brown, Keith Calloway, Colleen Coleman, Rachel Hart, Danielle, James, and Bennie Henderson.

This committee reviewed four programs for reaccreditation. They were assisted by FLETA OA Program Manager J.J. Hensley.

USDA, Agriculture Detector Dog Handler Training Border/Cargo/Parcel

Mr. Lachance called upon Mr. Bennie Henderson to recognize the USDA, Agriculture Detector Dog Handler Training Border/Cargo/Parcel for its second reaccreditation. The dates of the assessment were May 2-4, 2023 by means of a blended assessment (Newnan, GA & Remote), and the Team Leader was Rhonda Meehan, DCSA. The accreditation manager was Trent Adamson.

The purpose of the ADDHT-BCP is to provide a positive learning environment for training detector dog teams as a means of safeguarding American agriculture. This course prepares students to perform their occupational duties as canine handlers. Upon completion of the course, students work at various ports of entry. The ADDHT-BCP program is 50 instructional days and consists of 400 hours of instruction. The average number of iterations of the program is four.

Federal Probation and Pretrial Academy, Probation and Pretrial Services Office, Initial Probation and Pretrial Training Program

Mr. Lachance called upon Ms. Colleen Coleman to recognize the Federal Probation and Pretrial Academy, Probation and Pretrial Services Office, Initial Probation and Pretrial Training Program for its first reaccreditation. The dates of the assessment were August 8-10, 2023 by means of a blended assessment (Charleston, SC & Remote), and the Team Leader was Joan Chatmon, USPIS. The accreditation manager was Ethan Evans.

The purpose of the IPPT is to train newly appointed probation and pretrial services officers to perform the core duties of their positions in the safest manner possible. The IPPT is six weeks (29 instructional days) and consists of 220 hours of instruction. The average number of students per iteration of the program is 24.

United States Secret Service, Explosive Detection Canine Course

Mr. Lachance called upon Mr. Brent Brown to recognize the United States Secret Service, Explosive Detection Canine Course for its second reaccreditation. The dates of the assessment were June 6-8, 2023 by means of a blended assessment (Beltsville, MD & Remote), and the Team Leader was Stephen Golden, ICE. The accreditation manager was Tim Standish.

The purpose of the EDCC is to provide students with an in-depth understanding of basic principles of conditioning and basic obedience; to include identification of canine behaviors and verbal commands to control canines in a field environment. In addition, this course provides students with knowledge and hands-on experience in identifying changes of behavior in assigned canines. The EDCC is 85 instructional days and consists of 680 hours of instruction. The average number of students per iteration is 6-8.

United States Secret Service, Emergency Response Team, Tactical Canine Course

Mr. Lachance called upon Mr. Keith Calloway to recognize the United States Secret Service, Emergency Response Team, Tactical Canine Course for its second reaccreditation. The dates of the assessment were May 23-25, 2023 by means of a remote assessment, and the Team Leader was Molly Wankel, PhD, TSA. The accreditation manager was Tim Standish.

The purpose of the ERT TCC is to instruct students on how to care for their canine and kennel facilities, principles of canine conditioning and canine psychology; and transitioning the application of these learned techniques from the classroom to the field. Obedience and proper apprehension techniques using a canine are taught in the classroom and in the field. Students learn prescribed tactical techniques with team members and are trained to work in high-distraction environments under critical stress and conduct scenario training that requires students to apply the Use of Force policy reasonably, decisively, and effectively. The length of the ERT TCC is 55 instructional days and

consists of 440 hours of instruction. The average number of students per iteration of the program is four.

Mr. Lachance recognized Board Review Committee C led by Ms. Debra Kirby. Board members included: Ronald Athmann, Charles Daenzer, Kelly Lewis, Jacqueline Maguire, and COL. Andrea O'Connor.

This committee reviewed four programs for reaccreditation. They were assisted by FLETA OA Program Manager Christiana Halsey.

CBP Air and Marine Operations National Air Training Center, Survival Tactics Aviation Recurrent

Mr. Lachance called upon Ms. Debra Kirby to recognize the CBP Air and Marine Operations National Air Training Center, Survival Tactics Aviation Recurrent for its first reaccreditation. The dates of the assessment were July 18-20, 2023 by means of a blended assessment (Oklahoma City, OK & Remote), and the Team Leader was Julie Altman, FLETC. The accreditation managers were René Allen and Maggie McGee.

The purpose of the STAR program is to train Law Enforcement First Responders in medical care, land and water survival, off-duty carry tactics, legal updates, and active shooter response to armed Air and Marine Operations Agents through classroom and laboratory environments. The STAR program is five instructional days and consists of 40 hours of instruction. The number of students per iteration of the program is 18.

CBP Air and Marine Operations National Air Training Center, Survival Tactics Aviation Recurrent Non-6c

Mr. Lachance called upon COL Andrea O'Connor to recognize the CBP Air and Marine Operations National Air Training Center, Survival Tactics Aviation Recurrent Non-6c for its first reaccreditation. The dates of the assessment were August 1-3, 2023 by means of a blended assessment (Oklahoma City, OK & Remote), and the Team Leader was Lakeesha Mathews-Williams, NASA. The accreditation managers were René Allen and Maggie McGee.

The purpose of the STAR Non-6c is to train Law Enforcement First Responders in medical care, land and water survival for unarmed Air and Marine Operations Agents through classroom and laboratory environments. The STAR Non-6c program is two instructional days and consists of 16 hours of instruction. The number of students per iteration of the program is 18.

Homeland Security Investigations, Criminal Analyst Training (HSICAT)

Mr. Lachance called upon Mr. Charles Daenzer to recognize the Homeland Security Investigations, Criminal Analyst Training (HSICAT) for its first reaccreditation. The dates of the assessment were May 16-18, 2023 by means of a remote assessment, and the

Team Leader was Lisa Bak, FBI at the time of the assessment. The accreditation managers were Stephen Golden and Leon Carmichael.

The purpose of the HSICAT is to provide employees with the basic skills necessary to be an effective and successful Criminal Analyst while supporting HSI missions in a law enforcement environment. HSICAT is comprised of pre-course work, nine course modules, and a capstone exercise. This course enables Criminal Analysts, regardless of assignment and duty location, to produce Reports of Analysis and understand the tradecraft of criminal analysis in accordance with the HSI Framework for Criminal Analysis. The HSICAT is 25 instructional days and consists of 21 hours of pre-course work, and 200 hours of instruction. The average number of students per iteration of the program is 16.

Inspector General Criminal Investigator Academy (IGCIA), Inspector General Investigator Training Program (IGITP)

Mr. Lachance called upon Ms. Kelly Lewis to recognize the Inspector General Criminal Investigator Academy (IGCIA), Inspector General Investigator Training Program (IGITP) for its second reaccreditation. The dates of the assessment were August 15-17, 2023 by means of an in-person assessment, and the Team Leader was Elaine Wilson Harrison, ATF. The accreditation manager was Rachel Hart.

The purpose of the IGITP is to serve as a basic training program designed for newly hired GS-1811 criminal investigators in the federal Inspector General (IG) community. The IGITP was developed in collaboration with experienced OIG criminal Investigators from diverse cross-section of federal agencies. The IGITP is ten instructional days consisting of 77 hours of instruction. The average number of students per iteration of the program is 24.

X. Closing Remarks and Adjournment
