

Federal Law Enforcement Training Accreditation Board Board Meeting July 17, 2008 Clearwater, Florida

I. Call to Order

Commander Mark Wilbert, USCG, Chairperson, called the Board Meeting to order.

III. Welcoming Remarks and General Comments.

CDR Mark Wilbert introduced the Colors presented by the Pinellas County Sheriff's Honor Guard, and recited the Pledge of Allegiance.

Gary Mitchell introduced Sheriff Jim Coats, Pinellas County Sheriff's Office, who provided opening comments and welcomed the Board to Pinellas County. Sheriff Coates stated that as with all law enforcement agencies, the Sheriff's Department continues to face challenges in performing our duties due to budgetary cuts; however, with opportunities to partner with federal agencies we all operate better.

Sharon Henegan, the past Chairperson, announced that Board Officer Elections had been held in April – June 2008, and introduced the new FLETA Board Officers.

CDR Wilbert asked Director Connie Patrick, FLETC, to address the Board with comments about outgoing Chairperson Sharon Henegan, and to join him in presenting Ms Henegan with a plague from the FLETA Board. Ms Henegan provided comments to the Board, and she thanked the Board for the opportunity to have served as its Chair, and stated she will enjoy continuing to service the Board as a member.

CDR Wilbert and Ms. Henegan also provided words of thanks to John Moran (TSA), First Vice Chair; Charlene Lamb (DOS), Second Vice Chairperson; as they completed their terms of office and Mark Fallon (former NCIS), Board Member as he left the Board.

IV. Accreditation Awards

CDR Wilbert announced that the Board Review Committee (BRC) met on Wednesday, July 16, 2008, and conducted a review of the following;

U. S. Customs and Border Protection – Field Operations Academy Federal Law Enforcement Training Center – Land Management Police Training Program

Following the Board Review Committee review the Board went into Executive Session, and considered each program applying for accreditation.

CBP – **Field Operations Academy** (**CBP FOA**) – CDR Wilbert called upon Board Member, Mr. Tim Danahey, to report the results of the CBP Review. Mr. Danahey announced CBP had been unanimously approved for accreditation by the Board. Mr. Danahey called Darlene Langum Wilder, Deputy Director, to come forward and receive their certificate awarding Accreditation.

FLETC – Land Management Police Training Program (LMPT) – CDR Wilbert called upon Board Member, Ms Sue Leeds, DOI, to report the results of the LMPT Review. Ms Leeds announced LMPT had been unanimously approved for accreditation by the Board. This is FLETC's twelfth accreditation application; FLETC should be commended on their dedication to the FLETA Accreditation process. Ms Leeds called Director Patrick to come forward and receive their certificate awarding Accreditation.

CDR Wilbert expressed his thanks and gratitude to the Office of Accreditation staff, the Assessors, Team Leaders, and Accreditation Managers for their hard work, and making the process work. It is an efficient and effective way to make our government work.

V. Approval of Minutes

CDR Wilbert called for the Board to approve the minutes of the last meeting held March 13, 2008.

VI. Reports of Standing Committees

A. Bylaws Committee – Mr. Mark Spurrier

Mr. Mark Spurrier reported the Bylaws have been updated and adopted by the FLETA Board on Tuesday, July 15, 2008. The Bylaws will be posted on the FLETA website www.fleta.gov. Mr. Spurrier noted the Bylaws are a living document and will continue to evolve as the Board develops.

The FLETA Board also approved a motion and a follow-up motion that 1/3 of the Board Member terms will expire each year beginning in 2010. (See attached Board Membership memo).

The FLETA Board approved a motion that one of the non-voting (consulting) members of the Board member terms will expire each year beginning in 2010. (See attached Board Membership memo).

B. Standards Steering Committee (SSC) – Mr. Don Webb

Mr. Don Webb stated that the SSC met on Monday, July 14, 2008, and discussed Standards 1.04.05, 1.04.06, and 3.01.04

Mr. Webb provided recommended language from the Standard Steering Committee; the new standard language is to read as follows:

STANDARD: 1.04.05 - Training instruction is conducted in facilities that are in compliance with Environmental Protection Agency (EPA) regulations and standards, as well as state and local environmental requirements.

Compliance Indicator: A current completed EPA regulations and standards check sheet is on file. Training facilities are assessed to ensure compliance.

STANDARD: 1.04.06 - Training instruction is conducted in facilities that are in compliance with the Occupational Safety and Health Administration (OSHA) regulations and standards, as well as fire safety codes per the National Fire Protection Association (NFPA).

Compliance Indicator: A current completed OSHA check sheet is on file. A current completed NFPA check sheet is on file. Training facilities are assessed to ensure compliance.

STANDARD: 3.01.04 - Students who fail examinations or laboratory/practical exercise performance evaluations are provided remedial training and reevaluated.

Compliance Indicator: Documented administrative controls establish policies and procedures which address necessary steps to be followed in regard to student remediation and reevaluation.

The Standard Steering Committee recommended the FLETA Board adopt the new language as a *clarifying* change.

A motion was made by Mr. Tim Danahey to adopt the new wording for Standard 1.04.05, Standard 1.04.06, and Standard 3.01.04 to read as stated above, seconded by Mr. Mark Logan. There was no further discussion by the Board. The motion was passed unanimously. Standards will be updated, published, and reflected in a Revision Notice on the FLETA website www.fleta.gov. Changes will also be emailed to all Accreditation Managers.

CDR Wilbert thanked Mr. Don Webb and the members of the SSC for their work and commitment to the process of accreditation.

C. Membership Committee

CDR Wilbert reported the Chairperson received two new letters requesting FLETA Board membership since the last meeting. Letters were received from the National Park Service and the Pentagon Force Protection Police.

The Board currently has 22 positions filled and one vacant seat. The information was referred to the Executive Committee for review prior to the next FLETA Board Meeting.

VII. General Reports

A. FLETA Office of Accreditation – Mr. Gary Mitchell

Mr. Gary Mitchell reported on the FLETA Office of Accreditation accomplishments since the last Board Meeting, stating there are now 85 applications (24 Academies and 61 Programs). Five new (5) applications have been received and nine (9) applications for Reaccreditation. (See Executive Director's Report - attached.)

On Tuesday July 15, 2008, The FLETA Board provided Instruction Systems Development training to the accreditation community through Darryl Sink and Associates. Thirty-eight (38) people attended the training and reported training had been valuable.

FLETA will begin its first reaccreditation assessments in August 2008.

The next AM/ATP class is scheduled for September 23 – 25, 2008, in Chicago, Illinois.

Mr. Mitchell also listed the items which had been handled by the FLETA Board at this meeting.

- The accepted correspondence from NCIS concerning their Protective Services
 Operations Training Program which will be added to the FLETA assessment
 records.
- 2. The Senate Appropriations mark up directed "the FLETA Board to develop standards that require agencies seeking accreditation of their basic or entry-level law enforcement training programs to include comprehensive training on ethics and integrity" and report by December 1, 2008.
 - a. The Board directed the Standard Steering Committee to conduct a standard review and provide the Board with their recommendation.
 - b. The FLETA Office of Accreditation will review and report on the current ethics and integrity being provided.
 - c. The Executive Committee will prepare a response for submittal to Congress by December 1, 2008.
- 3. Mr. John Dooher confirmed the status of the FLETA Board in the pending FY09 appropriations bill. In the appropriations language both Houses have directed that FLETA stay in the FLETC budget for purposes of administration. The FLETA Board, however, is considered to be an independent body with authority to make binding decisions on behalf of its members and is not otherwise affiliated with FLETC.

4. Sign-up sheets were presented to the Board to gather names for the FLETA Board Committees – Bylaws, Strategic Planning, and Standards Steering. The Executive Committee is to be part of the Strategic Planning and the Budget Committees. (Attached is a list of Committees and members.)

B. FLETA Coalition – Mr. Al Wheaton

Mr. Al Wheaton reported on the Coalition's progress and announced their new board officers:

The Bylaws have been written, approved, and implemented. Mr. Wheaton thanked all members of the coalition for their work. The coalition takes their directions from the OA, and we will be looking for ways we can improve communications with the OA and the Board. The Coalition will be monitoring the upcoming reaccreditations in August. Mr. Wheaton thanked the Board for funding the training with Darryl Sink.

VIII. Old Business

Meeting Locations: The Board approved the following locations and directed the FLETA OA to solicit proposals from hotels to host upcoming meeting.

March/April 2009 Hilton Head, SC July 2009 Clearwater, FL November 2009 San Francisco, CA

These decisions were made after lengthy deliberation to ensure the Board was a good steward of the tax payers' dollars. The Board will be looking at developing a two-year plan for future meetings, so the OA can negotiate the lowest rates and save the tax payers' money.

FLETA Assessments (Tab 3)

April 14-18, 2008, FLETC – Land Management Police Training Program (LMPT) in Glynco, GA May 7-8, 2008, CBP - Field Operations Academy Follow-up in Glynco, GA

Five (5) assessors (and three shadow assessors) were used for a cost of \$4, 940. Assessors were from five (5) different agencies and averaged three previous assessment assignments. (Tab 7)

Funds were expended during the 2nd Quarter of FY 2008 for three activities; expenses related to the: FLETA Video, Darryl Sink & Associate training for the July 2008 meeting, FLETA public awareness, and attendance for Accreditation Managers from accredited agencies at the March 2008 meeting.

Month by Month Activities

April 2008

The Accreditation Manager and Assessor training programs were presented in Arlington, VA, at the DOT training center to 23 students.

We are working with Mr. Thomas Ward, FLETC's video producer to create a FLETA Informational video.

The Nominating Committee submitted a list of candidates for the FLETA Officers. Three elections were conducted between April and June before all the positions were filled.

We presented the FLETA process to the US Army Military Police at Fort Leonard Wood, Missouri.

A FLETA Assessment of the FLETC Land Management Training Program was conducted.

May 2008

A follow-up FLETA Assessment of the CBP Field Operations Academy was conducted.

Mr. Joe Augeri completed an internship working on the development phase of the Assessor Training Program.

We continued communication with Department of Education about DOE Recognition. Ms. Melissa Lewis, the Executive Director of the National Advisory Committee on Institutional Quality and Integrity is our point of contact and leads the group which recommends accrediting bodies to the DOE Secretary for recognition.

June 2008

The FLETA Program Manager positions were announced.

The Fundamental Guidelines and the FLETA Guide were posted on the FLETA website.

FLETA records were moved to Microsoft Access. This change will greatly increase our efficiency with our record keeping. Other upgrades will help us to maintain a secure paperless record keeping system.
