

Federal Law Enforcement Training Accreditation Board Board Meeting April 25, 2013 Glynco, Georgia

I. Welcoming Remarks and General Announcements

Chairperson Ronald Ward called the meeting to order at 8:30 a.m. He welcomed all attendees and asked everyone to stand for the presentation of the colors by the CBP Field Operations Academy Honor Guard. FLETA Board Member Commander Tom Walsh, USCG, led the meeting attendees in reciting the Pledge of Allegiance.

Executive Secretary Gary Mitchell called the roll and reported 16 members were present, which constituted a quorum (attendance sheet attached).

Mr. Ward reported that in December the FLETA Board held a special election as required by the FLETA bylaws to elect a new chairperson after Mr. Donald Webb's retirement. Mr. Ward was elected Chair, Ms. Angela Hrdlicka was elected 1st Vice-Chair, Mr. Brian Peters was elected 2nd Vice-Chair, and Ms. Theresa Stoop was appointed as the FLETA Board Parliamentarian.

Mr. Ward announced that Ms. Sally Livingston was honored as the 2012 Team Leader of the Year at last night's FLETA recognition and awards ceremony. This award recognizes individuals who have contributed significantly or demonstrated exceptional commitment while serving in a Team Leader capacity during the FLETA accreditation process. Certificates of appreciation were also presented to more than 20 assessors from the last two cycles of assessments.

Mr. Ward recognized the assessors, Team Leaders, and everyone else who makes FLETA a success.

II. Approval of Minutes from Previous Board Meeting

Mr. Ward asked for a motion to approve the minutes from the July 12, 2012, FLETA Board meeting in Glynco, Georgia; the November 27, 2012, FLETA Board Conference Call meeting; and the February 21, 2013, FLETA Board Conference Call meeting.

Ms. Theresa Stoop made the motion, Ms. Angela Hrdlicka seconded the motion, and the motion carried unanimously.

III. Committee Reports

Three of the Board standing committees met on Tuesday of this week to conduct business. Mr. Ward called upon the committee chairs to report on the committees' activities.

A. Standards Steering Committee – Mr. Brian Peters reviewed the makeup of the committee and said they went over the committee processes and reviewed the committee charter. They tabled several issues until they can do some research. There

will be a total review of the FLETA Standards in 2015 and Mr. Peters said that the committee will take comments and suggestions in 2014 for that review. The Board has assigned several areas for the committee to look at, including the requirement that an agency's instructor training program must be accredited before their academy can be accredited. The Board wants to ensure FLETA adds value and is not burdening agencies unnecessarily.

Mr. Ward called for a motion to accept the Standards Steering Committee report. Mr. Michael Browning made the motion, Ms. Theresa Stoop seconded the motion, and the motion carried unanimously.

- **B.** Bylaws Committee Ms. Theresa Stoop reported that the Bylaws Committee will be looking at several items, including the need to document the review of the FLETA Standards, and adding language about the Strategic Plan to Article 2, Mission, Vision, and Goals.
 - Mr. Ward called for a motion to accept the Bylaws Committee report. Col. Kristine Blackwell made the motion, CMDR Thomas Walsh seconded the motion, and the motion carried unanimously.
- C. Awareness and Recognition Committee Ms. Cynthia Atwood reported that the Awareness and Recognition Committee had a lively discussion about how to enhance awareness of FLETA. Their ideas include developing a clean, succinct video, possibly in the vein of "We are FLETA", with different agencies' seals or logos. Ms. Atwood welcomed anyone to send their ideas to her.
 - Mr. Ward called for a motion to accept the Awareness and Recognition Committee report. Mr. Brian Peters made the motion, Mr. Michael Browning seconded the motion, and the motion carried unanimously.

IV. General Reports

- **A.** Office of Accreditation Updates Dr. Gary Mitchell reported that at the end of today's meeting there will be 15 accredited academies and more than 80 accredited programs, many of which are already into their second reaccreditation cycle. The full report of the FLETA Office of Accreditation activities is attached.
- **B.** Future Meetings Dr. Mitchell reported that the next FLETA Board meeting is scheduled for July 9-11, 2013. The location is still in the process of being determined, and more information will be posted on the FLETA website as it becomes available.

D. FLETA Agency Recognition Award – Mr. Ward asked Ms. Connie Patrick, Director of the Federal Law Enforcement Training Centers, to come forward. He then announced that the FLETA Board was pleased to recognize the FLETC as the first agency to receive the FLETA Agency Recognition Award.

The FLETA Agency Recognition Award is the highest award given by the FLETA Board to those organizations that have a long-standing history of outstanding contributions to, and in superior support of, the FLETA mission and process. The FLETC was tasked by the Office of Management and Budget to lead the development of an independent federal law enforcement accrediting process and, once the FLETA Board was established, the FLETC continued to support the process by providing resources, space, and countless assessors. The FLETA Board commends and thanks the FLETC and Director Patrick for the continued and invaluable support of the FLETA vision and mission.

Director Patrick received the award, congratulated the FLETA Board and accreditation community, and thanked them for their hard work to help develop the next generation of trainers.

E. FLEAC Report – FLEAC Chairman Jason Worchel gave the following report:

The Federal Law Enforcement Accreditation Coalition (FLEAC) conducted its regularly scheduled business meeting at 1500 hours on Wednesday, April 24, 2013. FLEAC Chairman Jason M. Worchel presided over the meeting.

The Coalition approved minutes of the July 10-12, 2012 meeting held at FLETC-Glynco and heard reports from the Coalition sub-committees: Membership (Kay Arthur), Standards (Sally Livingston), By-Laws (Dr. Mark Haucke), Training (Kim Canitz), Reaccreditation (Natasha Fulmore, not in attendance), and Communications (Donna Folmar, not in attendance).

As per the FLEAC By-Laws, this meeting was designated for the election of a FLEAC member to serve as the Vice-Chairperson for the next two years. It gives me great pleasure to announce that Dr. Michael McDade of the U.S. Customs and Border Protection (CBP) has been re-elected and will serve an additional two years as the Vice-Chairman of the FLEAC.

The Office of Accreditation also provided the FLEAC with an update and answered questions. Christiana Halsey discussed the on-line self-assessment initiative and future roll-out of the new ISCR forms.

The April 24, 2013, meeting was duly adjourned at 1544 hours to reconvene at the Summer FLETA Board meeting location.

All old business was handled through the Board's Committees' work.

VII. New Business

Following the Board Review Committees, the FLETA Board met in Executive Session Wednesday afternoon and reviewed each application for accreditation or reaccreditation. The Board unanimously approved each application for accreditation/reaccreditation.

Ms. Angela Hrdlicka began by recognizing Board Review Committee A, which was led by Brian Peters, and included Cynthia Atwood, Robert Cagle, Michael Delgado, Michael Hillyard, and Mike Novak. They reviewed four programs for initial accreditation, and two programs and two academies for reaccreditation. They were assisted by Office of Accreditation (OA) Program Manager Robert Bruton.

Mr. Peters recognized the *U.S. Marine Corps Police Academy Basic Police Officer Course* for initial accreditation. He reviewed the program and noted it presented the Board with a unique situation: due to sequestration the academy personnel were unable to travel to this meeting. Because of that, the program review was conducted via a teleconference call. Mr. Peters announced the Board unanimously approved the USMC Police Academy BPOC for initial accreditation.

Mr. Delgado recognized the *Defense Criminal Investigative Service Special Agent Basic Training Program* for initial accreditation. He reviewed the program and announced the Board unanimously approved the DCIS SABT program for initial accreditation.

Mr. Peters recognized the *U.S. Army Military Police School Special Victims Unit Investigations Course* and the *U.S. Army Military Police School Staff and Faculty Training Course* for initial accreditation; the *U.S. Army Military Police School Civilian Police Academy* for program reaccreditation; and the *U.S. Army Military Police School* for academy reaccreditation. He reviewed each program/academy and announced the Board unanimously approved the USAMPS SVUIC and SaFTC for initial accreditation, the Civilian Police Academy for reaccreditation, and the Military Police School for academy reaccreditation.

Mr. Cagle recognized the *Air Force Office of Special Investigations Basic Special Investigators Course* for reaccreditation and the *U.S. Air Force Special Investigations Academy* for reaccreditation. He reviewed each, noting the AFOSI staff excelled in instructor development and have a quality process. He then announced the Board unanimously approved both the AFOSI BSIC and the USAF Special Investigations Academy for reaccreditation.

Ms. Hrdlicka next recognized Board Review Committee B, which was led by herself, and included Pat Corcoran, William Fallon, James Gregorius, Nancy Stout, and Thomas Walsh. BRC B reviewed four programs for initial accreditation, and four programs and one academy for reaccreditation. They were assisted by OA Program Managers Billy McLeod and Christiana Halsey.

Ms. Hrdlicka recognized the *James J. Rowley Training Center* for academy reaccreditation and the *U.S. Secret Service Essentials of Instruction Course* for reaccreditation, noting that both are in their second cycle of reaccreditation. She also mentioned that she found it commendable that the USSS used evidence in their folders from five unaccredited programs at the USSS Academy, showing their commitment to the FLETA process. She then announced the Board unanimously approved the USSS James J. Rowley Training Center and the Essentials of Instruction Course for reaccreditation.

Mr. Fallon recognized the *Bureau of Alcohol, Tobacco, Firearms and Explosives Industry Operations Investigator Basic Training Program* and the *Special Agent Basic Training Program* for initial accreditation. He reviewed both programs and announced the Board unanimously approved the ATF IOIBT and SABT programs for accreditation.

Mr. Gregorius recognized the *Federal Air Marshal Service Defensive Measures Instructor Training Program* and the *Instructor Development Course* for initial accreditation. He reviewed both programs and announced the Board unanimously approved both programs for initial accreditation.

Mr. Corcoran recognized four programs of the Federal Law Enforcement Training Centers for reaccreditation: Boat Operators Anti-Terrorism Training Program, Inland Boat Operator Training Program, Law Enforcement Control Tactics Instructor Training Program, and Law Enforcement Instructor In-Service Training Program. He reviewed each program briefly and announced the Board unanimously approved all four programs for reaccreditation.

Ms. Hrdlicka recognized Board Review Committee C, which was led by Colonel Kristine Blackwell, and included Michael Browning, Curtis Smith, and Theresa Stoop. They reviewed four programs for initial accreditation, and four programs and one academy for reaccreditation. They were assisted by OA Program Managers Christiana Halsey and C.J. Ross.

Colonel Blackwell recognized the *U.S. Coast Guard Boarding Officer Practical Course* for initial accreditation, reviewing the program and noting the Coast Guard team gave a very professional demonstration. She then announced the Board unanimously approved the USCG BOPC for initial accreditation.

Mr. Browning recognized the *Dept. of Veterans Affairs Instructor Development Course* for initial accreditation, noting the assessment team gave high marks to the VA Law Enforcement Training Center. He then announced the Board unanimously approved the course for initial accreditation.

Ms. Stoop recognized two *Office of Personnel Management* programs for initial accreditation: the *Federal Background Investigator Training Program* and the *Office of Personnel Management Essentials of Suitability Adjudication Program*. She gave a brief review of each program and announced the Board unanimously approved both programs for initial accreditation.

Dr. Smith recognized the *Customs and Border Protection Basic Entry Specialist Training Program* and the *CBP/Border Patrol Task-Based Language Teaching Program* for reaccreditation. He reviewed each program and announced the Board unanimously approved both programs for reaccreditation.

Colonel Blackwell recognized the *Internal Revenue Service Special Agent Basic Training Program* and the *Basic Instructor Facilitator Training Program* for reaccreditation, and the *National Criminal Investigation Training Academy* for reaccreditation. She reviewed both programs and the academy and announced the Board unanimously approved all three for reaccreditation.

VIII. Closing Remarks and Adjournment of the Open Session

Board Chairperson Ronald Ward again thanked everyone for attending the Board meeting. He then recognized and thanked the Executive Committee and recognized the Office of Accreditation. Mr. Ward commented he is proud of how agencies come together through the FLETA process. He asked everyone to help promote FLETA within their own agencies and get the word out about FLETA. If anyone has ideas about how to promote FLETA, please send them to Board member Ms. Cynthia Atwood, FLETC, or Dr. Gary Mitchell, FLETA OA Executive Director. Mr. Ward also said the accreditation community will be notified about details of the July Board meeting as soon as they are known. Mr. Ward then adjourned the meeting at 9:40 a.m.

Assessors (Tab 6)

Thirty-three assessors (18 less than last cycle), 11 OJT/shadow assessors (seven less than last cycle), and 34 self-assessors (14 less than last cycle) were used, for a total cost of \$29,249.28 (\$31,980.69 less than last cycle). Assessors were from 22 (-7) different agencies, averaged 2 (-2.375) FLETA assessments per assessor, and participated in an average of 1 (-3.3243) self-assessments per assessor. The average cost/assessment was \$2,659.03, as compared to \$3,601.76 from the previous period.

Additional Activities by Month

October 2012

CBP/BP withdrew their Firearms Instructor Training Program from review at the fall Board meeting because CBP is creating an overarching firearms instructor program for all CBP employees, including CBP/BP.

Mr. Mitchell received a request from CBP Assistant Commissioner Chris Hall to meet with the FLETA Board to talk about CBP accreditation plans. The meeting was scheduled for October 30, 2012 at the Baltimore Board meeting.

November 2012

The 10th Anniversary portfolio and video were posted to the FLETA website.

The Board Executive Committee met on November 8th at the FLETA/OA offices.

Kevin Miller (ICE) completed his 60-day Executive Leadership assignment with the Office of Accreditation.

A full FLETA Board meeting via conference call took place on November 27th. The main topics were planning for the next Board meeting, April 23-25, 2013, and election of Board officers. The also discussed future Board meetings and possible meeting locations.

Nominations opened for the FLETA Board Chairperson position.

December 2012

The election began for the FLETA Board Chairperson. The formal election was necessary because of the Bylaws requirement of a written ballot. Mr. Ward was elected FLETA Chairperson.

Nominations and election for the FLETA Board's First Vice-Chair position were held. Ms. Angela Hrdlicka was elected FLETA First-Vice Chairperson.

Nominations for the FLETA Board's Second Vice-Chair were taken, and the election period began. The election closed on January 3rd, 2013.

Mr. Terry Stuart was presented with a FLETA Certificate of Appreciation at his retirement ceremony.

The OA received notice from FLETC that their total rollover for the XSE incentive fund was \$18,832.15, providing an additional \$8,000 in the fund for FY13.

January 2013

The election process for the FLETA officers was completed. The FLETA Officers are:

These officers will serve in their respective positions until July 2014.

The FLETA Board has two new members:

- 2) Michael Delgado, Assistant Inspector for General Investigations, TIGTA Headquarters Operations, replacing Mr. Terry Stuart

Mr. Keith Hill advised Mr. Mitchell that he is retiring from federal service at the end of January.

The OA received notice that the request to hold the April Board meeting in Baltimore, MD had been denied by the Federal Law Enforcement Training Centers' CFO. The OA is looking at the possibility of holding the Board meeting at FLETC in Glynco, GA.

February 2013

The State Department appointed Ms. Nancy Stout to replace Kevin Bauer.

Billy McLeod and Gary Mitchell traveled to Washington, DC February 19th and 20th. They met with FMCSA, U.S. Capitol Police, FLETC Cheltenham, DHS, and new Board member Michael Delgado.

The OA responded to a DHS request for additional information on all meetings FLETA has scheduled in FY13, including estimates of number of attendees to the meetings.

Mr. Mitchell received new budget numbers for travel for the rest of FY13. The maximum that will be allowed to be obligated for FY13 is \$61,000 for ACC and \$148,300 for XSE.

A "special called" FLETA Board meeting conference call was held on February 21st. All Board members attended. The main topics were budget discussion and approval of the April Board meeting location being changed to Glynco.

DHS requested additional information on the April Board meeting request. The meeting approval request package is now being submitted to the Deputy Secretary.

Mr. Mitchell prepared a FLETA financial history for Board review.

John Waters from FMCSA visited the FLETA offices and worked with FLETA/OA Program Manager Christiana Halsey to prepare a plan for FMCSA's reaccreditation efforts.

March 2013

The request for the April Board meeting is being reviewed by the DHS Deputy Secretary.

The FLETA Executive Committee met at the OA offices on March 12th.

FLETA/OA staff met with the former FLETC Evaluation and Analysis Branch, which is FLETC's evaluation and analysis unit, to provide information about the FLETA process and standards. The meeting was well received.

In a conference call with the FRB in Atlanta, we were told that they were turning away meeting requests based upon holding space for the FLETA Board meeting in July. The FRB said they needed to know by the end of April 2013 if the FLETA board was going to meet in Atlanta.

In the FLETC FY2012 Impact Report prepared for DHS, the FLETA and/or accreditation were mentioned 20+ times. It was also noted that the FLETA Board met on the FLETC campus for their July 2012 Board meeting.
